

24D Programs for First and Second Offense DUIs

In Massachusetts, first and second DUI offenders can get something called a **24D disposition**. Under Massachusetts General Laws [Chapter 90, Section 24D](#), qualifying cases will be [continued without a finding](#) and the defendant placed on probation for no more than two years.

Additionally, the defendant who successfully gets a 24D must enroll and successfully complete a **driver alcohol education program**. The program options are different based on location and the court. Below is a list of the approved programs:
